

## **Moral Injury Panel (CO State Library) - November 17, 2023**

### **Definitions**

**Moral Injury** - “Moral injury is the damage done to one’s conscience or moral compass when that person perpetrates, witnesses, or fails to prevent acts that transgress one’s own moral beliefs, values, or ethical codes of conduct.” (Moral Injury Project, Syracuse University)

#### **What It’s Not:**

**Burnout** - “Burnout is a form of exhaustion caused by constantly feeling swamped. It’s a result of excessive and prolonged emotional, physical, and mental stress. Burnout happens when you’re overwhelmed, emotionally drained, and unable to keep up with life’s incessant demands.” (WebMD)

**Compassion Fatigue** - “Compassion fatigue is the cost of caring for others or for their emotional pain, resulting from the desire to help relieve the suffering of others. It is also known as vicarious or secondary trauma, referencing the way that other people’s trauma can become their own.” (Canadian Medical Association)
